Minutes of a Meeting held on Wednesday 23 January 2019 in Scaleby Village Hall at 7.30pm

258/19 Apologies for Absence

Apologies were received from County Cllr J Mallinson.

259/19 Minutes of Meeting Held Wednesday 21 November 2018

Resolved that the minutes of the last meeting of the Parish Council be agreed and signed by the Chairman as a true record with the addition of Cllr Marston being included in the attendance register.

260/19 Requests for Dispensations

No requests for dispensations were received.

261/19 Declarations of Interest

Cllr Little declared an interest under item 267/19.

262/19 Public Participation

City Cllrs Bowman and Bainbridge requested opinions from Cllrs regarding the use of the Sands Centre facilities. It was explained that the redevelopment is to focus upon sports/swimming facilities rather than the entertainment aspect of the existing venue.

It was noted that Cllrs Bowman and Bainbridge are both to stand in alternate wards in the City area in the May 2019 elections and, due to the new boundaries, three new Cllrs would be in attendance from May. It was confirmed that Scaleby fall into the new large Longtown & the Border ward.

Parish Council elections are also to take place in May and members were asked to spread the word to any residents who may be interested in standing.
