# 158/17 Public Participation

City Cllr Bowman noted that the City Council had been consulting on reviewing their Street Trading Policy. The Clerk clarified it had not appeared for discussion on the agenda as the deadline had passed the previous month and each Parish Council was only given a few days notice to respond. City Cllr Bowman also noted that training is to be offered for both the Clerk and Chairman of each Parish Council in the district on the requirements for making declarations of interest. Finally Cllr Bowman also enquired as to how the extended kerbside recycling service was working.

# 159/17 Financial Matters

# 159.1 Statement of Accounts to 30 June 2017

**Resolved** that the account summary for the period ended 30 June 2017 be noted.

A discussion regarding the potential need for money for a new website was considered; the Clerk is to try and apply for grant monies before the issue is considered further. A query was raised as to whether the website could be created in conjunction with another parish – the Clerk to investigate all possibilities.

# 159.2 Donation for Training Course in Village Green Management

**Resolved** to donate £25 towards the total training costs in respect of the Clerk attending the above course (payable to Stanwix Rural Parish Council). It was agreed to place the management and maintenance of the Village Greens on a future agenda for consideration.

#### 160/17 Highways Matters

**Cllr Little** noted concerns regarding the positioning of a high kerb at Longpark and noted a cone had been placed at the area as a warning of the danger to passing vehicles. The Clerk to report the kerb to Highways.

Ongoing concerns over the surface of the A6071 were also noted although it was believed that surface dressing is scheduled to take place in August. The Clerk is also to confirm with County Cllr Mallinson if any progress has been made with the Horsgills signpost as previously mentioned.

# 161.1 Litter Picking

It was noted that the use of the Community Payback team did not appear to be viable due to the process and lack of response from the providers to date and that their use should not continue to be investigated.

**Resolved** to hold a community litter pick on Wednesday 12<sup>th</sup> September at 6.30pm meeting at the Village Hall. Cllr McGarr to be responsible for the risk assessments and health and safety requirements as the Clerk submitted apologies for the date in advance.

It was noted that three summer play days will take place on 8<sup>th</sup>, 15<sup>th</sup> and 22<sup>nd</sup> August. Flyers have been distributed around local schools.
