Resolved that the minutes of the last meeting of the Parish Council be agreed and signed by the Chairman as a true record.

200/18 Declarations of Interest

No declarations of interest were made.

201/18 Public Participation

No members of the public were present. City Cllr Bainbridge informed Cllrs that his small scale grants budget was open for applications.

203/18 Highways Matters

The previously mentioned signpost at Horsegills was discussed - the Clerk to seek reassurances that it will be replaced following two accidents at the junction. It was queried whether double white lines on the stretch of road would also be advantageous?

Cllr McGarr noted the confusing notifications sent from Highways with regards to forthcoming road closures. City Cllr Bainbridge to feedback to those responsible.

Various potholes are to be reported to Highways (south of Hunley lonning, Chapel Lane and on the Horsegills road). It was also noted that the verges are in a poor state.

Cllr Moore informed members that he had repaired a fingerpost recently following a vehicle collision.

Resolved: Clerk to report potholes and chase Horsegills signage.

204.1 Website

204.5 Play Scheme 2018

Resolved to host two days, from 9am to 4pm, at an increased cost of £6 per child. Dates to be set in conjunction with the providers and the Village Hall.

204.6 Fidelity Insurance Guarantee

Resolved to accept the review of PC fidelity insurance as being adequate for the current financial year.

204.7 General Data Protection Regulations

Cllrs were informed that little progress has been made since the January meeting, with national bodies still to provide confirmation as to whether the Clerk will be able to act as the DPO in certain size Parish Councils. Due to this it was considered that

delegated authority be given to the Clerk to appoint a suitable DPO once guidance is provided.

Cllrs signed receipt for a copy of a postcard "We're getting ready for GDPR. Are you?"; "Preparing for the General Data Protection Regulation 12 Steps to take now" and an "introduction to the 12 steps" as it was noted that the Council as a body corporate is responsible for the implementation of GDPR and that the regulations apply to Cllrs as well as the Clerk. Updated policies and procedures are being worked on to ensure that compliance is present throughout the Council.

Resolved: To delegate authority to the Clerk to incur reasonable expenditure for the appointment of a Data Protection Officer.

204.8 Electoral Review of Carlisle: Warding Arrangements

City Cllr Bainbridge gave Cllrs an overview of the reasoning behind the review and outlined potential scenarios for the proposed new ward arrangements, being either Carlisle, Brampton or Longtown orientated.

Resolved to respond to the consultation to specify that Scaleby wishes to be included in a Carlisle facing ward.
